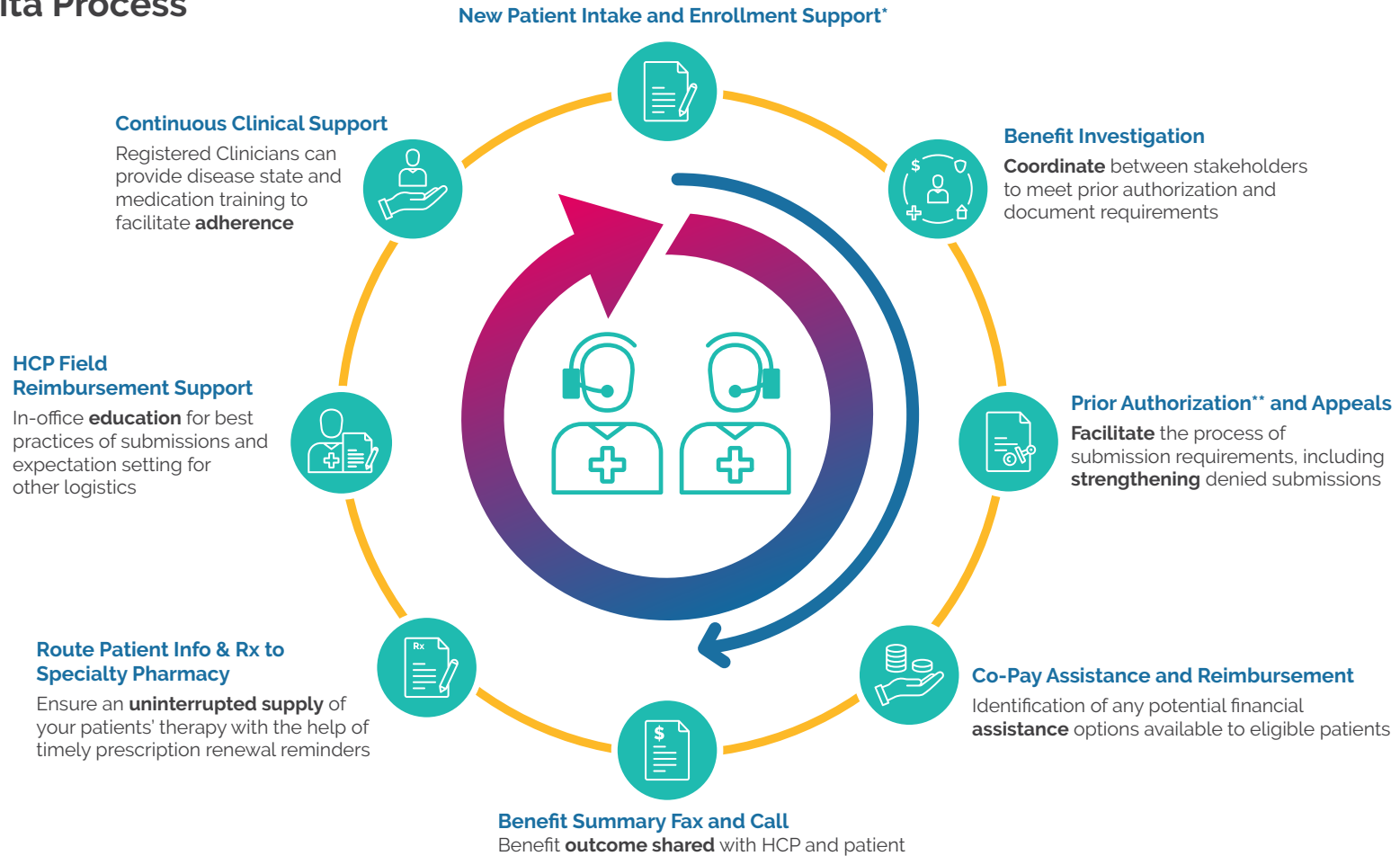
**Medication Adherence Support** - Clinical Education Managers can provide disease state and medication training to facilitate adherence.
